The Mission of Ukraine to the European Union presents its compliments to the General Secretariat of the Council of the European Union and has the honor to acknowledge the receipt of the General Secretariat's Note N SGS20 / 002361 of 11 June 2020, concerning the proposal to renew the Agreement on cooperation in science and technology between Ukraine and the European Community, signed in Copenhagen on 4 July 2002, which entered into force on 11 February 2003 and has been renewed on 8 November 2004, on 21 December 2011 and on 17 August 2015, for an additional period of five years.

The Mission of Ukraine to the European Union, on behalf of Ukraine, confirms that this proposal is acceptable to Ukraine. Consequently, the Note of the General Secretariat of the Council of the European Union and this Note in reply shall constitute an agreement to renew the Agreement on cooperation in science and technology between Ukraine and the European Community for an additional period of five years, with effect from 8 November 2019. The renewal of the aforementioned Agreement shall enter into force on the date of the last notification on the completion by the Parties of their necessary internal procedures.

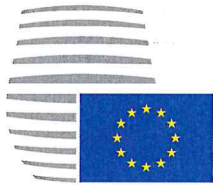
The Mission of Ukraine to the European Union avails itself of this opportunity to renew to the General Secretariat of the Council of the European Union the assurances of its highest consideration.

## NOTE VERBALE

The General Secretariat of the Council of the European Union presents its compliments to the Mission of Ukraine to the European Union and has the honour to refer to the renewal of the Agreement on cooperation in science and technology between the European Community and Ukraine, signed at Copenhagen on 4 July 2002, which entered into force on 11 February 2003 and has been renewed on 8 November 2004, on 21 December 2011 and on 17 August 2015, and in particular to Article 12(b) of the Agreement.

The General Secretariat of the Council further has the honour, on behalf of the President of the Council, to notify the Mission of the approval, by the European Union, of the renewal of the aforementioned Agreement for an additional period of five years.

The General Secretariat of the Council proposes that this Note Verbale and a Note in reply from Ukraine shall constitute the common agreement between the Parties to renew the Agreement for an additional period of five years, effective as from 8 November 2019, which shall enter into force on the date of the last notification on the completion by the Parties of their necessary internal procedures.

The General Secretariat of the Council of the European Union avails itself of this opportunity to renew to the Mission of Ukraine to the European Union the expression of its highest consideration.
